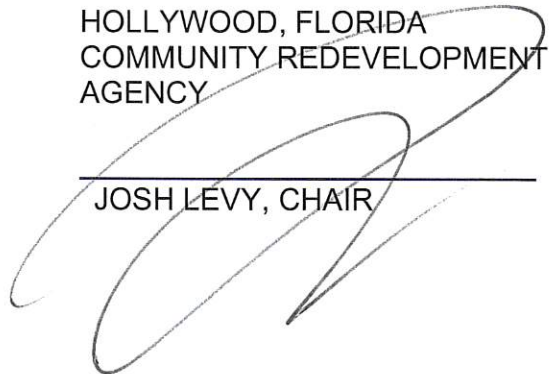

9. **COMMENTS BY BOARD MEMBERS, GENERAL COUNSEL AND EXECUTIVE DIRECTOR**

Board member Shuham, District 1

Lent

Board member Shuham wished everyone celebrating Lent a season of reflection, a good and meaningful one.

Parking

Board member Shuham advised that Hollywood Beach residents are interested in holding a parking study/workshop where they can address their issues and concerns..

Ordinances

Board member Shuham requested support from the Board to direct staff to research the ordinances of other cities as it applies to delivery trucks, tents on the Beach and the zoning for building height. On a voice vote the Board provided full support for staff to research delivery trucks and the zoning for building height.

Enhanced Services

Board member Shuham advised that a budget adjustment was made when the CRA code enforcement officers were repositioned to the City.

Board member Hernandez, District 2

Parklet

Board member Hernandez provided the Board with an update of the Parklet meeting with downtown business owners interested in the Parklet program. He further advised that he is looking forward to the expansion of the program and an update from staff will be provided at an upcoming meeting.

Parking

Board member Hernandez requested support from the Board to have the executive director explore a potential lease agreement for parking lots located at the Bank of America building and Suntrust Tower. He also suggested staff look into the lift parking system. The Board provided support to these requests.

Vice chair Callari, District 3

Mural Project/The Ugly Wall

Vice chair Callari thanked Bettina August for her effort and contribution in organizing the Sheridan Street Mural Project also known as The Ugly Wall.

### Saint Patrick's Day

Vice chair Callari invited everyone to come out and celebrate the St. Patty's Day Parade on Sunday, March 10, 2019 on Hollywood Boulevard.

### Hollywood Beach Lifeguard Stands

Vice chair Callari advised that the old lifeguard stands will be auctioned and she further suggested that the funds be donated to a program such as the mural project.

### Murals

Vice chair Callari thanked Jill Weisberg for the mural presentation and stated that we should be very proud and excited about the program and the exposure it gives our City.

### Board member Blattner, District 4

#### Florida Department of Transportation (FDOT)

Board member Blattner stated in regards to the concerns presented during citizen comments, FDOT is a big organization but it seems as if there is a communication breakdown based on the presentation presented earlier. He encourage staff to work closely with them to address residents concerns.

### Board member Biederman, District 5

#### Citizens' Comments

Board member Biederman requested that the executive director address the issues and concerns presented during Citizens' Comments. He further shared a quote by Shirley Chisholm, that you don't make progress by standing on the sidelines, whimpering and complaining. You make progress by implementing ideas.

### Hollywood Beach Parking

Board member Biederman reminded the Board that the Scott Street parking spaces were eliminated due to landscaping, trees and curb appeal but also for electrical purposes. He further advised staff to look into the configuration of the parking spaces.

#### Parking

Board member Sherwood advised the Board of a correspondence received from a resident about the vacant parking spaces along Munroe and Van Buren Streets during the Vintage South Florida event. She further stated that staff should take into consideration all options related to parking during events and further advised that the lift parking system is a great idea.

Federal Highway

Chair Levy informed the Board of the future FDOT project for Federal Highway in 2020. He requested that staff meet with all parties involved in the organizational process to be able to inform business owners and residents of what to expect from the project.

Downtown Hollywood

Chair Levy advised the Board that he is actively working with downtown property owners regarding vacant storefronts and the leases.
